Climbing Wall Rules and Regulations

- *All Climbers must weigh at least 45 pounds and must sign a “waiver and Release” below
- *Climbers under the age of 18 must have the “Waiver and Release” form signed by a parent or legal guardian
- *All climbers must comply with the judgments of the Blazer’s Fun Zone staff on duty.
- *No hard-soled shoes will be permitted on the climbing surfaces. Athletic shoes are recommended.
- *No horseplay permitted on or around the rock climbing landing area.

Waiver and Release:

I, undersigned, understand that in consideration of using the climbing walls, equipment and/or participating in activities sponsored by Blazer’s Fun Zone (BFZ), I must obey all the (BFZ)’s climbing wall rules and regulations as well as read and agree to the following Waiver and Release. I also acknowledge that there are significant elements of risk in any adventure, sport, or activity associated with a rock climbing wall or inflatable fun equipment.

Although we have taken reasonable steps to provide you with the appropriate equipment and/or skilled staff so you can enjoy an activity for which you may not be skilled, we wish to remind you that this activity is not without risk. Certain risks cannot be eliminated without destroying the unique character of the activity. The same elements that contribute to the unique character of the activity can be causes of accidental injury such as; neck and back strains, muscle strains, muscle pulls, tendon and ligament damage as well as other typical athletic injuries or in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for this activity, but we do think it is important for you to know in advance what to expect and to be informed of the inherent risks.

I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

I the undersigned user, agree to release on behalf of myself, any heirs, representatives, successors, executors, administrators and assigns, and HEREBY DO RELEASE BLAZER’S FUN ZONE, a Kentucky corporation, it’s officers, agents, and employees from any cause of action, claims or demands of any nature whatsoever, including but not limited to. A claim of NEGLIGENCE, which I, my heirs, representatives, successors, executors, administrators and assigns may now have, or have in the future against BLAZER’S FUN ZONE on account of personal injury, death or accident of any kind, arising out of or any way related to my use of the climbing wall or other inflatable equipment whether that use is supervised or unsupervised, however the injury or damage is caused, including but not limited to, the NEGLIGENCE of BLAZER’S FUN ZONE, it’s officers, agents or employees. Should BLAZER’S FUN ZONE or anyone acting on their behalf, be required to incur attorney’s fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I certify that I have adequate insurance to cover my injury or damage I may cause or suffer while participating or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against BLAZER’S FUN ZONE on the basis of any claim from which I have released them herein. I agree that if any portion of this legal agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
